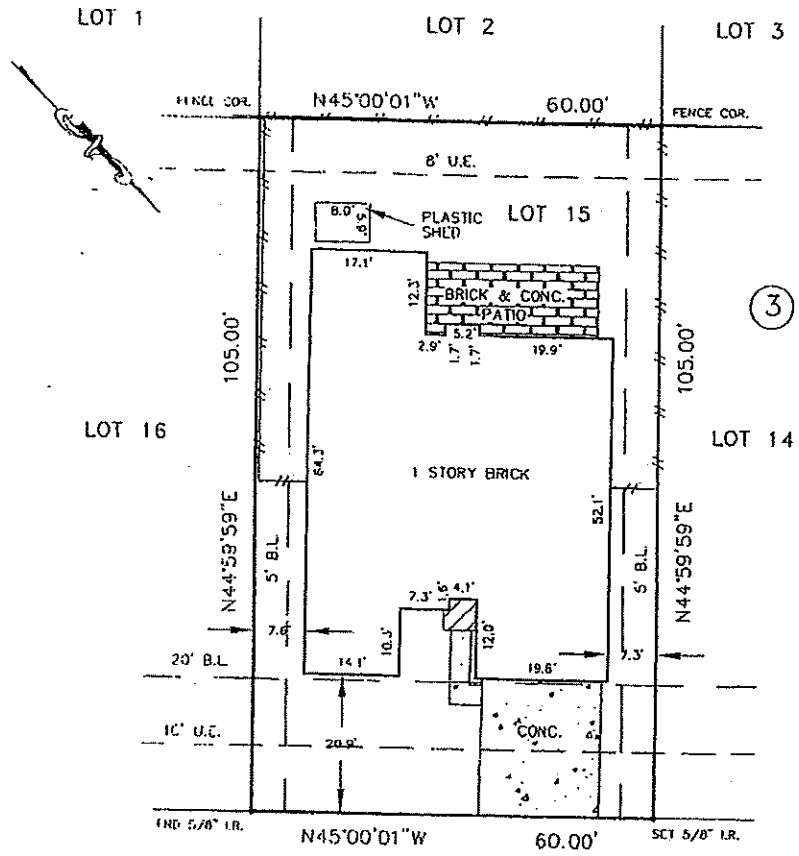


This property is located in the 100 year flood plain & is in insurance rate zone 2, as per map 48074C 0055J dated 9-28-99
