AND BEING MORE PARTICULARLY DESCRIBED BY METES AND BOUNDS AS FOLLOWS: (BEARINGS ARE BASED IN C.C.F. No. T879995, O.R.H.C.T.)

BEGINNING at a found 5/8" iron rod in the southerly right-of-way (ROW) line of Tall Cedars Drive (60' ROW) for the common Northeast corner of herein described Tract, the common northerly corner of Lots 105 and 106 and the northwest corner of Lot 106 conveyed to Donald R. Cox, recorded in C.C.F. No. R579917, O.R.H.C.T.;

THENCE SOUTH, 90.00', departing the southerly ROW line of said Tall Cedars Drive and along the common East line of herein described Tract, the west line of said Lot 106 conveyed to Donald R. Cox and the common division line of said Lots 105 and 106, to a point for the common Southeast corner of herein described Tract, the southwest corner of said Lot 106 conveyed to Donald R. Cox, the northeast corner of Lot 132 conveyed to Donald R. Cox, recorded in C.C.F. No. R579917, O.R.H.C.T. and the common corner of Lots 105, 106, 131 and 132, from which a found ½" iron rod Bears S43°31'20"E, 0.72';

THENCE S 60°00'00" W, 127.78', along the common Southerly line of herein described Tract, the northerly line of said Lot 132 conveyed to Donald R. Cox and the common division line of Lots 103, 104, 106 and 132, to a point for the common Southwest corner of herein described Tract, the southeast corner of Lot 102 conveyed to Reginaldo Mandujano, recorded in C.C.F. No. 20070077241, O.R.H.C.T. and the common corners of Lots 102, 103, 132 and 133;

THENCE N 29°31'48" W, 124.73', along the common Westerly line of herein described Tract, the easterly line of said Lot 102 conveyed to Reginaldo Mandujano and the common division line of said Lots 102 and 103, to a found 5/8" iron rod in the southerly ROW line of said Tall Cedars Drive and a curve to the right for the common Northwest corner of herein described Tract, the northeast corner of said Lot 102 conveyed to Reginaldo Mandujano and the common northerly corner of said Lots 102 and 103;

THENCE in a Northeasterly direction along the common Northerly line of herein described Tract, the southerly ROW line of said Tall Cedars Drive and said curve to the right having a RADIUS of 349.26', DELTA of 29°31'45", LENGTH of 180.00', CHORD BEARING of N75°14'03"E and a CHORD LENGTH of 178.02' to the POINT OF BEGINNING.
