Field Notes Description

0.22 acres of land out of the H. Austin Survey, Abstract 4, Colorado County, Texas, being part of Block 98 in the City of Weimar and conveyed by Richard E. and Joan Fay Walker to Patrick and Amelia Sainz in Warranty Deed with Vendor's Lien dated October 21, 2002 and recorded in Volume 417, Page 10 of the Official Records of Colorado County, Texas.

Being more fully described by metes and bounds as follows:

BEGINNING: at a 1/2" iron rod, (Y = 13,811,118.50, X = 2,670,965.20), found at the northwest corner of a 0.26 acre tract conveyed to Suzanne Sanders in Volume 831, Page 890 of the Official Records of Colorado County, Texas, and in the east line of a 0.32 acre tract conveyed to Joseph Miller, Jr. and Kari Miller in Volume 102, Page 188 of the Deed Records of Colorado County, Texas, for the southwest corner of this herein described tract;

THENCE: N 04°11'49" E -along the east line of said 0.32 acre tract and the west line of this herein described tract at 29.56 feet past a 2-1/2" iron pipe found for a line marker, in all a total distance of 69.42 feet, to a 5/8" iron rod with cap stamped "RPLS 6368" set at the southwest corner of a 0.38 acre tract conveyed to Paul H. and Maxine Billeck in Volume 328, Page 214 of the Deed Records of Colorado County, Texas, for the northwest corner of this herein described tract;

THENCE: S 84°04'36" E -138.40 feet along the south line of said 0.38 acre tract and the north line of this herein described tract to a point at the southeast corner of said 0.38 acre tract and in the west right of way line of North West Street, for the northeast corner of this herein described tract, whence a found 3/8" iron rod bears S 51°43'44" E -0.72 feet;

THENCE: S 04°41'35" W -69.84 feet along the west right of way line of said North West Street and the east line of this herein described tract to an "X" scribed in concrete at the northeast corner of said 0.26 acre tract, for the southeast corner of this herein described tract;

THENCE: N 83°53'44" W -137.81 feet along north line of said 0.26 acre tract and the south line of this herein described tract to the *POINT OF BEGINNING*, containing within these metes and bounds a 0.22 acre tract, more or less.
