THENCE S 87° 33' 15" E, along the common line of the herein described tract and said 2.9226 acre tract, a distance of 493.45 feet to an iron rod found in the west right-of-way (R.O.W.) line of Moonlight Trail (60 feet R.O.W.) marking the northeast corner of the herein described tract and the southeast corner of said 2.9226 acre tract;
