The above rates represent the current annual fees assessed by the Community.

Annual Assessments are due on January 1st.

Payments not received by the **close of business on January 31**st are considered late and will be assessed applicable penalties. Any payments received on or after February 1st are late. Mailing/Postmark, E-Check, and Credit Card processing dates will not be accepted. Penalties are assessed based on the <u>received</u> date. It is recommended that a minimum of 7 days be allowed for mail and 3 days be allowed for credit card/online payments.

Note that a **separate payment** is required for each assessment owed; **one combined payment will not be accepted**. You will receive individual invoices for each Association (**Bridgeland Council, Lakeland Village, Parkland Village, Prairieland Village, Townhome Association**).

<u>Online Payments</u>: As a reminder, you may be charged a merchant fee for credit/debit payments. E-Check payments are free. The online payment portal link and approved 2022 Annual Budget will be posted on our website. Note that a **separate payment** is required for each assessment owed when using the online payment portal. Your account numbers and Association ID's can be found on their respective invoices. For your reference, the Association ID's are as follows: Bridgeland Council – 121, Lakeland Village – 122, Parkland Village – 124, Prairieland Village – 126, The Townhomes at Lakeland Heights – 119, Harmony Grove – 120.

<u>Payment Plans</u>: Residents may request an automatic 3-month payment plan by submitting a <u>written request</u> to the Association <u>before the January 1st due date</u>. The plan will divide your current year's assessments into 3 equal monthly payments, which will be due no later than January 31st, February 28th, and March 31st. Extended payment plans will be considered on a case-by-case basis based on circumstance. Accounts that have defaulted on a payment plan within the previous 2 years *may* not be eligible for a current payment plan.
