Notice to a Purchaser of Real Property in a Water District

1) The real property, described below, that you are about to purchase is located in the Galveston Co MUD # 15 District. The district has taxing authority separate from any other taxing authority and may, subject to voter approval, issue an unlimited amount of bonds and levy an unlimited rate of tax in payment of such bonds.
