Dear Owner:

This letter is to serve as a reminder that you own property in a historic district. Galveston is known nationwide for its historic architecture, cultural and historical traditions and for the preservation of these resources. Each of Galveston's four historic districts has a unique sense of place and receives protection under the Land Development Regulations.

The Historic District regulations are administered by the City's Planning and Development Division and the Galveston Landmark Commission. Here are some resources that are available to you, as an owner in a historic district:

- The Planning and Development Division has staff members with Historic Preservation expertise. The staff is here to assist you with any questions that you have about your historic property and to guide you through the review process. Most projects can be administratively approved through the building permit process. The office is located on the 4th Floor of City Hall, 823 Rosenberg. Staff can be reached at 409-797-3660 or planningcounter@cityofgalveston.org.
- The Landmark Commission is the review board for the historic districts. It is a citizen board that is charged with reviewing the rehabilitation, restoration, new construction, and demolition of buildings within the historic districts. If Landmark Commission review is needed, the staff is here to help you through the process.
- The Design Standards for Historic Properties document is a tool used by staff, homeowners, and the Landmark Commission to review and approve proposed projects. The Design Standards contain a wealth of information and can be downloaded from the City's website at:
