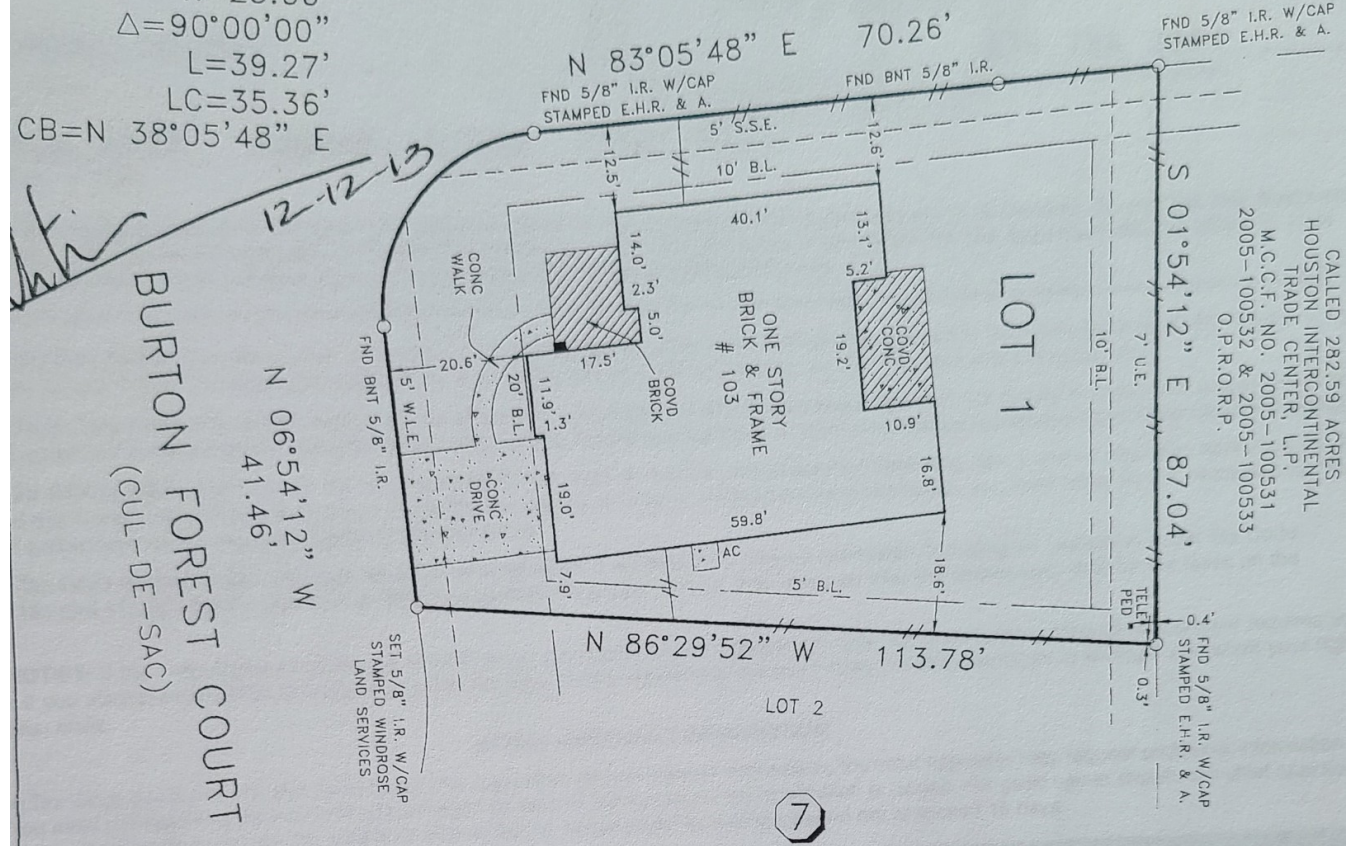


HENDRICKS FOREST LN. (60' R.O.W.)

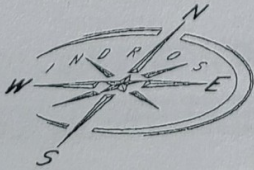
