1) The real property, described below, that you are about to purchase is located in the <u>Fort Bend MUD NO.5</u> District. The district has taxing authority separate from any other taxing authority and may, subject to voter approval, issue an unlimited amount of bonds and levv an unlimited rate of tax in payment of such bonds. As of this date, the rate of taxes levied by the district on real property located in the district is $\frac{0.91}{2}$ on each \$100 of assessed valuation. The district may exercise the authority without holding an election on the matter. As of this date, the most recent amount of the standby fee is $\frac{0.00}{2}$. An unpaid standby fee is a personal obligation of the person that owned the property at the time of imposition and is secured by a lien on the property. Any person may request a certificate from the district stating the amount, if any, of unpaid standby fees on a tract of property in the district.
