## DESCRIPTION OF A 4.99 ACRE TRACT OF LAND SITUATED IN THE J.A. DAVIS SURVEY, A-188 MONTGOMERY COUNTY, TEXAS

No. 2002130740, said 4.99 acre tract being more particularly described by metes and bounds as follows:

BEGINNING at a $3 / 8$-inch iron rod found for the Northeast corner of said 2.00 acre tract, same being the Northwest corner of a called 5.00 acre tract recorded under M.C.C.F. No. 8541950, and on the South right-of way line of Rocky Road (right of-way varies), from which a $3 / 8$-inch iron rod found for the Northeast corner of said 5.00 acre tract bears N $86^{\circ} 00^{\prime} 46^{\prime \prime} \mathrm{E}$, a distance of 330.24 feet;

THENCE, $\mathrm{S}^{2} 03^{\circ} 31^{\prime} 22^{\prime \prime} \mathrm{E}$, with the line common to said 2.00 acre tract and said 5.00 acre tract, a distance of 658.46 feet to a $3 / 8$-inch iron rod found for the South common corner of said 5.00 acre tract and said 3.00 acre tract, same being in the North line of a called 4.000 acre tract described in M.C.C.F. No. 2000026674;

THENCE, S $86^{\circ} 30^{\prime} 07^{\prime \prime} \mathrm{W}$, with the line common to said 4.000 acre tract and said 3.00 acre tract, a distance of 329.83 feet to a railroad spike found next to a chain-link fence corner post for the West common corner of said 4.000 acre tract and said 3.00 acre tract, from which a sucker rod found at the South corner of a called 4.10 acre tract described in M.C.C.F. Document No. 296933 bears S $04^{\circ} 40^{\prime} 38^{\prime \prime}$ E, a distance of 46.93 feet;

THENCE, $\mathrm{N} 03^{\circ} 28^{\prime} 51^{\prime \prime} \mathrm{W}$, with the line common to said 3.00 acre tract and said 4.10 acre tract, a distance of 660.40 feet to a $3 / 8$-inch iron rod found for the Northwest corner of said 3.00 acre tract, same being on the South right-of-way line of said Rocky Road;

THENCE, N $86^{\circ} 50^{\prime} 21^{\prime \prime} \mathrm{E}$, a distance of 329.36 feet to the POINT OF BEGINNING and containing 4.99 acres of land.

Bearing orientation is based upon GPS observations, Texas State Plane Coordinate System, Central Zone, NAD-83. This metes in bounds description is being issued in conjunction with a survey plat of even date.
