Von Roeder Survey, Abstract 579 of Colorado County, Texas, and being that same tract as conveyed to Steve Naskrent and wife, Clarine Naskrent as recorded in volume 449, page 330 of the Deed Records of Colorado County, Texas, and being more particularly described as follows;

BEGINNING at a 1/2" iron rod found in the Northwest line of Sealy Road for the South corner of a William Haley tract (volume 473, page 248 and volume 475, page 115) and for the Southeast corner hereof;

THENCE with the Northwest line of Sealy Road South 73 deg. 55 min. 00 sec. West 339.55 feet to a 5/8" iron rod found for the Southeast corner of a Tonja Gilliam tract (volume 360, page 722) for the Southwest corner hereof;

THENCE with the Northeast line of the Gilliam tract and the Northeast line of an Oliver Weishuhn tract (volume 360, page 730) North 14 deg. 54 min. 57 sec. West 1047.04 feet to a 5/8" iron rod found for an interior corner of the Weishuhn tract and for the Northwest corner hereof;
