THENCE, North 69 deg. 14 min. 01 sec. West, with the North line of said Kitchen Hill Lane 55.00 feet to the Southwest corner of said Lot 25, Block 1, same being the Southeast corner of Lot 24, Block 1;



THENCE, with said common lot line, South 20 deg. 45 min. 59 sec. West, 104.00 feet to the POINT OF BEGINNING.


