Previous Foundation Repairs – Foundation work was done in 2003 and 2007 and is still under warranty by Du-West. This can be transferred to buyer.

Previous Roof Repairs – Limb fell and damaged shingles on roof near kitchen entrance door to upstairs deck. This was repaired in Feb 2021.

Water Damage Not Due to a Flood Event – Leak from master bedroom toilet in Aug 2021 - damage to downstairs bedroom and garage ceiling. A/C condenser leak Dec 2021 - damage to upstairs living room ceiling. Both repaired.

Previous treatment for termites or WDI – No previous issues, but it has been treated under termite contract with Scott's Pest Control.
