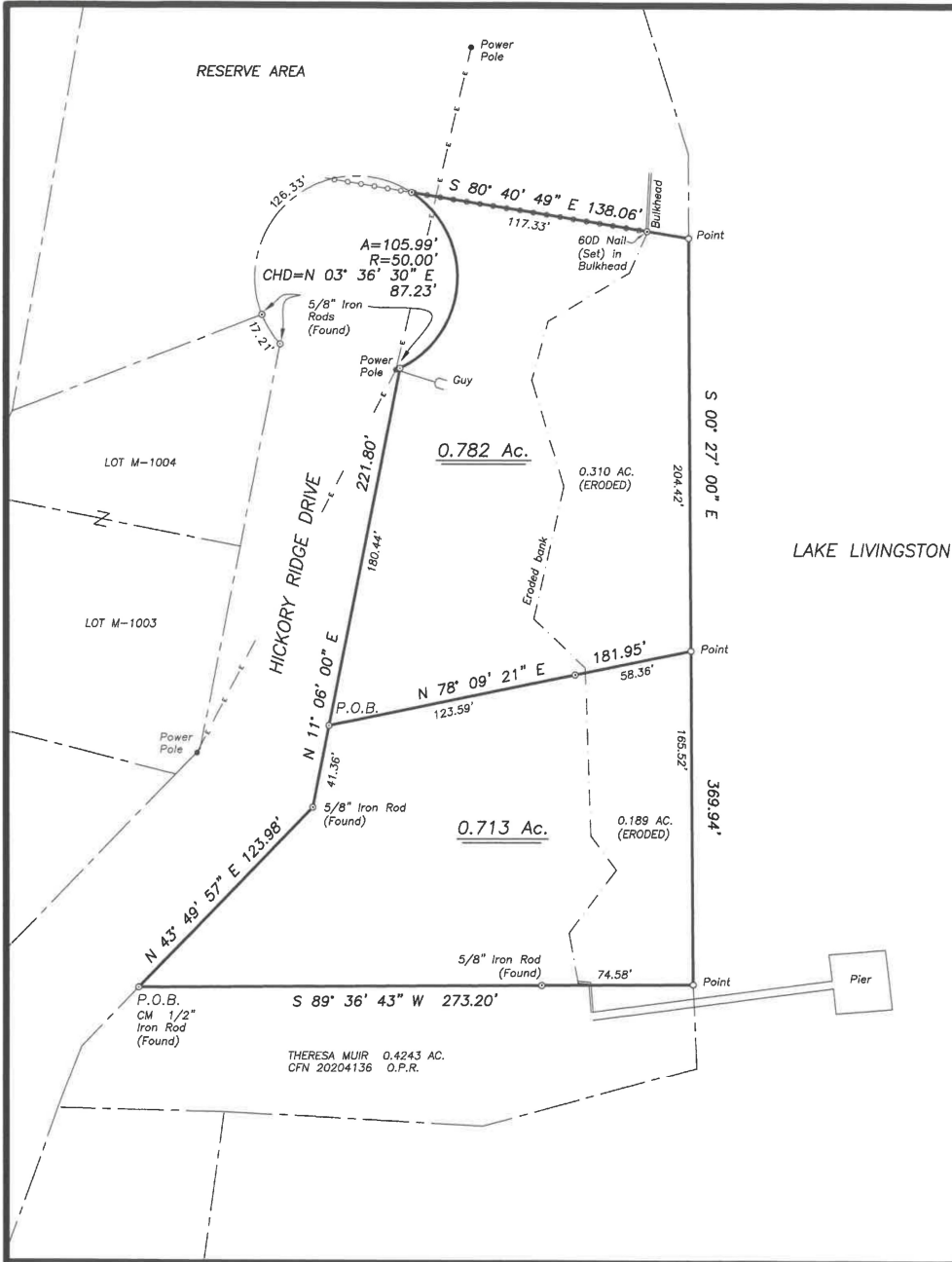
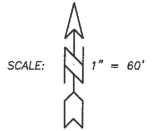


RESERVE AREA
