COMMENCING at a ¾" iron pipe found in Northwest right-of-way line of Live Oak, (being a 60' R.O.W., Vol. 3, Pg. 73, P.R.B.C.), for the Southwest corner of the aforesaid tract 18;

THENCE North 19° 45' 00" West – 830.00 feet along the common line of said tract 18 and tract 19 of said Mrs. Lucy Hervey S/D No. 1 of the S/D of tract 20C to a point for the Northwest corner of a called 2.5 acre tract conveyed to Mark A. and Tina L. Miles recorded in County Clerk's File No. 1993-043457 of the official records of Brazoria County, Texas;

THENCE North 70° 15' 00" East – 384.00 feet along the Northwest line of said Miles tract to a ½" PVC pipe found in concrete for the Southwest corner and TRUE PLACE OF BEGINNING of the herein described 1.03 acre tract;

THENCE North 19° 45' 00" West – 163.00 feet to a ½" iron rod set for the Northwest corner of the herein described 1.03 acre tract, from which a ¾" iron pipe found in concrete bears North 59° 42' 58" West – 1.56 feet;

THENCE North 70° 15' 00" East – 276.00 feet to a ¾" iron pipe found in the Southwest right-of-way line of Live Oak, (being a 60' R.O.W., Vol. 3, Pg. 73, P.R.B.C.), and the Northeast line of said tract No. 18 for the Northeast corner of the herein described 1.03 acre tract;

THENCE South 19° 45' 00" East – 163.00 feet along the Southwest right-of-way line of said Live Oak and the Northeast line of said tract No. 18 to a ¾" iron pipe found in concrete for the Northeast corner of the aforesaid Miles tract and being the Southeast corner of the herein described 1.03 acre tract, from which a ½" iron pipe found for the Southeast corner of a called 2.5 acre tract conveyed to J.D. & Louise Graham recorded in Volume 904, Page 225 of the deed records of Brazoria County, Texas bears South 19° 45' 00" East – 330.00 feet;

THENCE South 70° 15' 00" West – 276.00 feet along the Northwest line of said Miles tract to the PLACE OF BEGINNING and containing 1.03 acres of land, more or less. This description is based on an actual survey made on the ground and is accompanied by a plat prepared under the direct supervision of George K. Lane, RPLS No. 6086, on January 20th, 2009.


