Thence a called N 89 deg. 42 min. 02 sec. W and held for bearing basis along the common line and existing barb wire, wrought iron and field wire fences of the herein described 10.128 acre tract and the adjoining 4.7374 and 15.164 acre tracts, at 1748.24 feet pass a capped iron rod found in the centerline of a 60 foot wide road easement at 2397.92 feet pass a 3/4" iron pipe, at 2429.64 feet to a called 4" fence post falling within the waters of the San Bernard Rivers edge;
