FIELD NOTE DESCRIPTION 0.337 ACRES IN THE THOMAS DEVERS SURVEY, ABSTRACT NUMBER 170, LIBERTY COUNTY, TEXAS

BEING a 0.337 acre tract of land, situated in the Thomas Devers Survey, Abstract Number 170, Liberty County, Texas, and being all of that same called 0.3370 acre tract known locally as Lot 11, Block 4, of Briar Oaks Subdivision (unrecorded subdivision), described in instrument to Dearld Edward McMaster, recorded in Volume 1579, on Page 420, of the Official Public Records of Liberty County, Texas (O.P.R.L.C.T.), said 0.337 acre tract being more particularly described by metes and bounds as follows:

BEGINNING at a 3/4 inch pinched top iron pipe found in the the easterly margin of County Road 3252 (CR 3252), for the common westerly corner of said Lot 11 and that certain called 0.3370 acre tract known locally as Lot 12, of said Block 4, described in instrument to Gilbert Penton, II, recorded under Clerk's File Number 2003009682, O.P.R.L.C.T., being the southwesterly corner of the herein described 0.337 acre tract, from which a 5/8 inch iron rod found for reference bears South 00°02'47" East, 99.86 feet;

THENCE North 00°04'38" West, 100.02 feet, and the easterly margin of said CR 3252, the westerly line of said Lot 11, to a 3/4 inch pinched top iron pipe found for the common westerly corner of said Lot 11 and that certain called 0.3370 acre tract known locally as Lot 10 of said Block 4, described in instrument to Gilbert Penton, II, recorded in Volume 1917, Page 486, O.P.R.L.C.T., being the northwesterly corner of the herein described 0.337 acre tract;

THENCE North 89°50′56" East, 146.86 feet, with the common line between said Lot 11 and said Lot 10, to a 3/4 inch pinched top iron pipe found in the westerly line of that certain called 0.6198 acre tract known locally as Lots 23 and 24, of said Block 4, described in instrument to Jorge Zalazar and Patricia Baeza, recorded under Clerk's File Number 2021046809, O.P.R.L.C.T., for the common easterly corner of said Lots 11 and 10, being the northeasterly corner of the herein described 0.337 acre tract, from which a 5/8 inch iron rod found for reference bears North 00°10′11" West, 100.14 feet;

THENCE South 00°05'42" East, 99.80 feet, with the common line between Lot 11 and said Zalazar tract, to a 3/4 inch pinched top iron pipe found for the common corner of said Lot 11, said Zalazar tract, said Lot 12, and that certain called 0.3099 acre tract known locally as Lot 25 of said Block 4, described in instrument to Veronica Felts, recorded under Clerk's File Number 2007075170, O.P.R.L.C.T., being the southeasterly corner of the herein described 0.337 acre tract, from which a 5/8 inch iron rod found for reference bears North 89°59'51" East, 135.09 feet;

THENCE South 89°45'43" West, 146.89 feet, with the common line between said Lot 11 and said Lot 12, to the **POINT OF BEGINNING**, containing a computed area of 0.337 acres of land within this Field Note Description.

This Field Note Description was prepared from a survey performed on the ground on February 15, 2022, by Texas Professional Surveying, LLC., Registered Professional Land Surveyors and is referenced to Survey Drawing Project Number 23055.
