

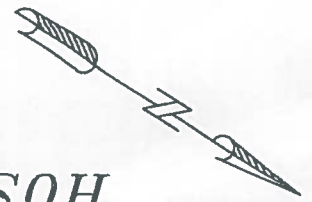

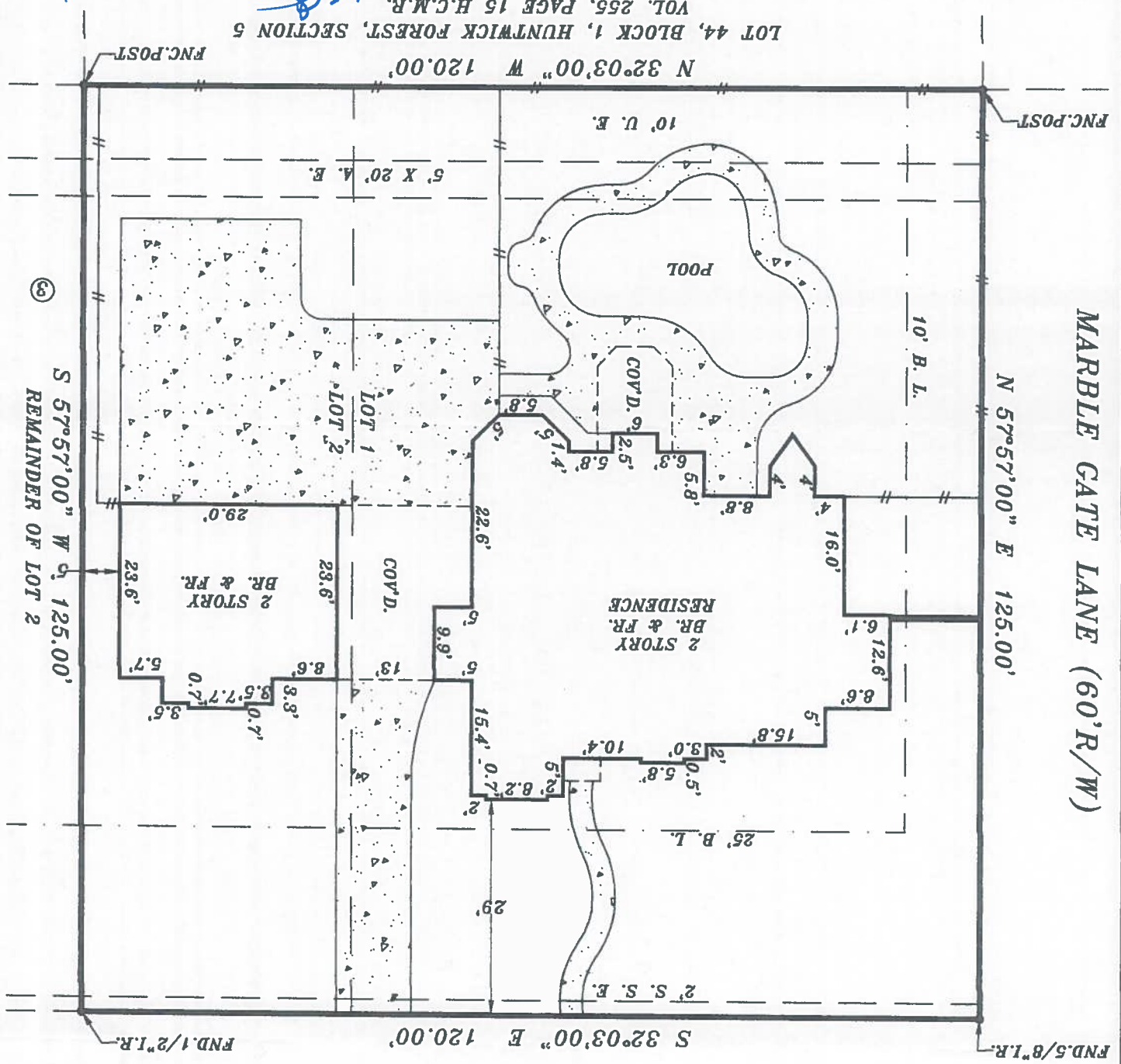

BENFER ROAD (60'R/W)

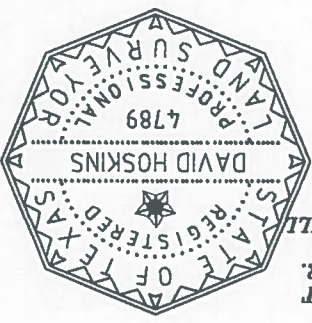
