

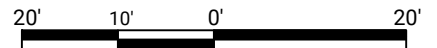

RESERVE "A"

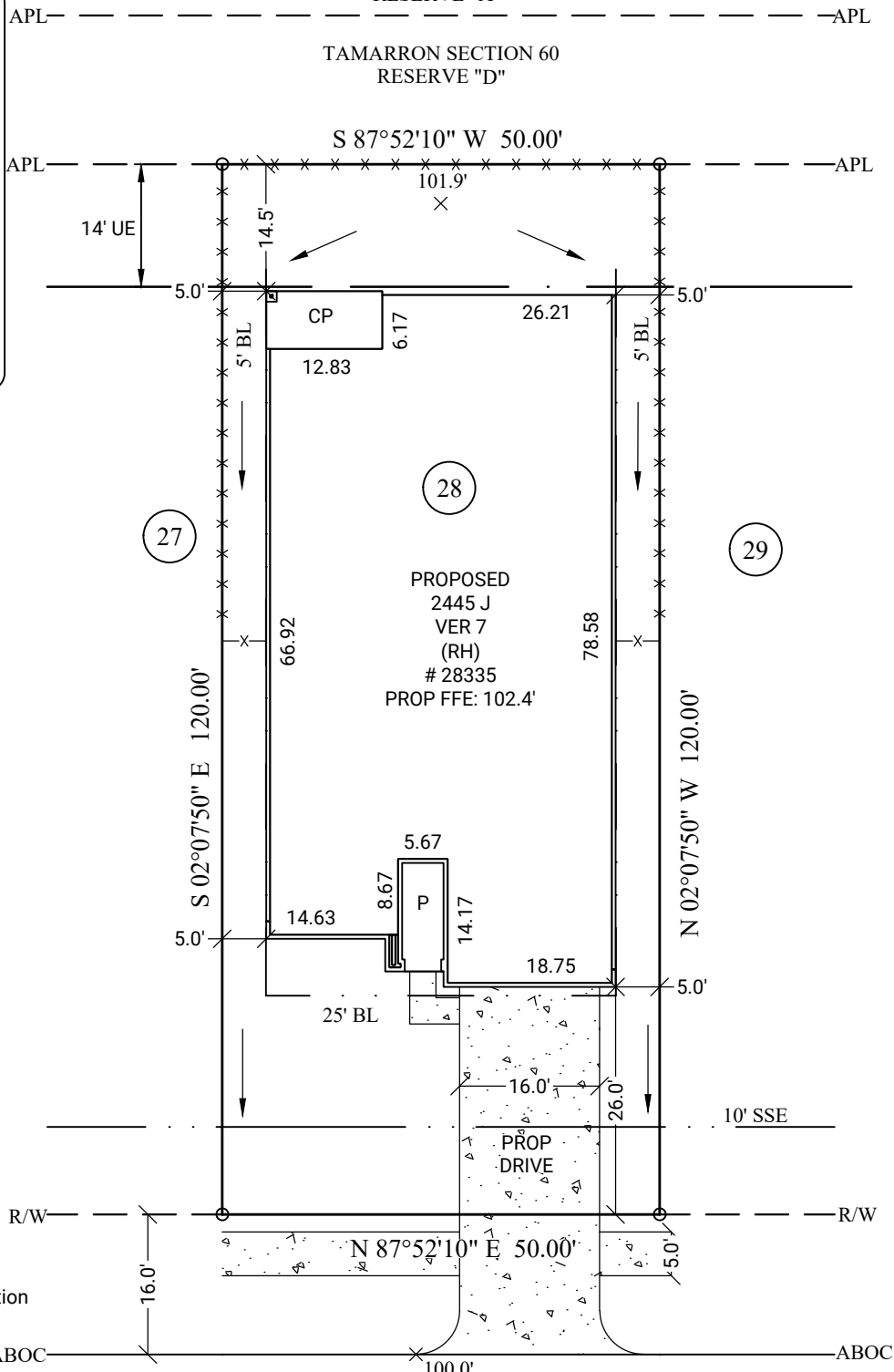
