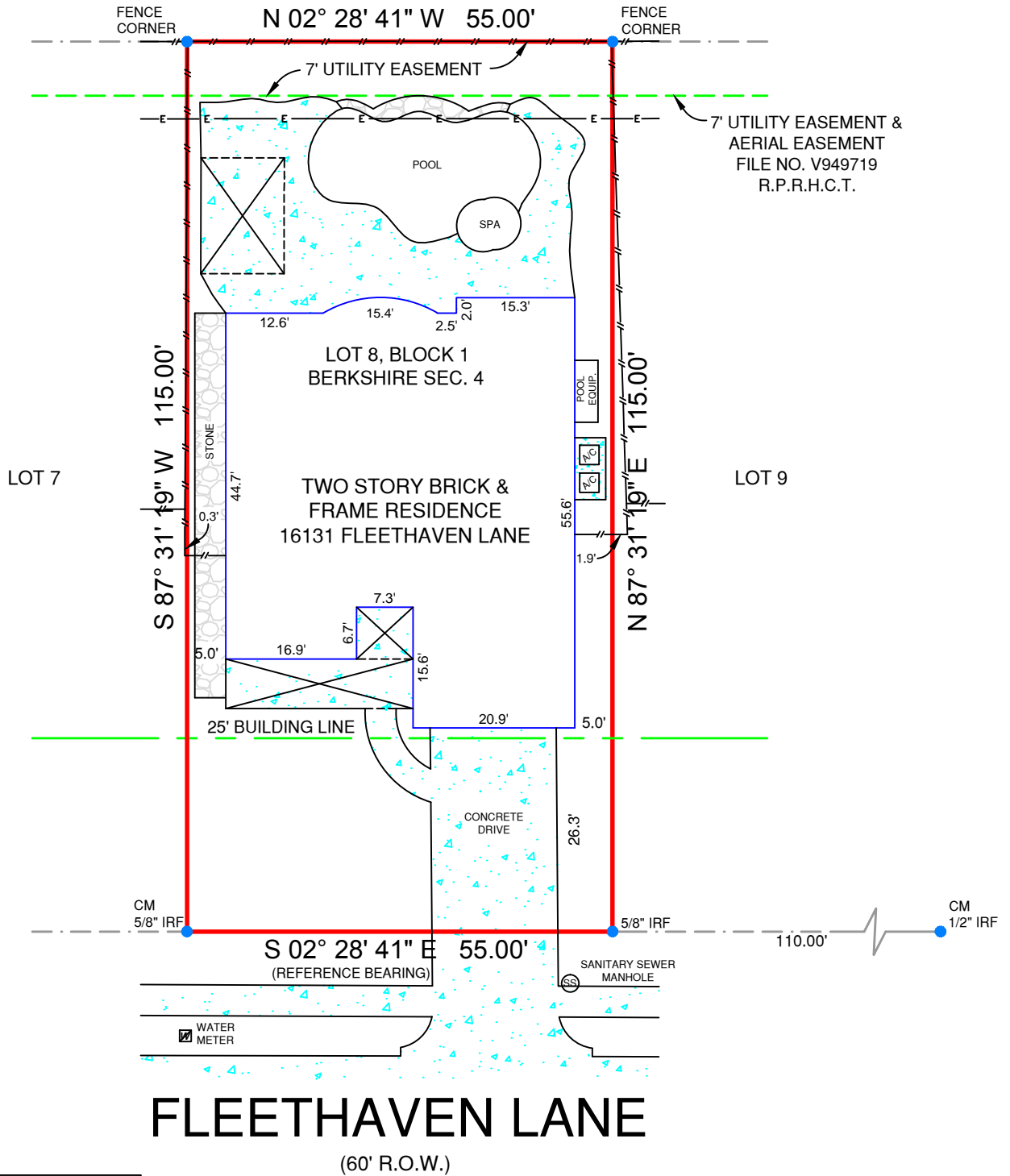

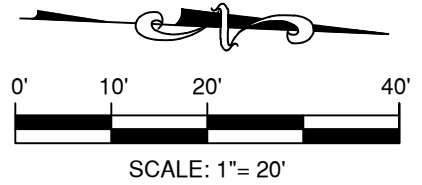


FLEETHAVEN LANE
