C.H. RUSHING SURVEY ABSTRACT 814

TRINITY COUNTY

All of that certain lot, tract, or parcel of land situated in the C.H. Rushing Survey, Abstract 814, Trinity County, Texas and being a portion of a called 339.362 acre tract known as Tract No. 5 described by deed recorded in Volume 739, Page 380 Deed Records, Trinity County, Texas, and being more fully described by metes and bounds as follows.

BEGINNING at a point for the northwest corner of this tract located in the center of Forest Road 501 on the south line of the I. & G.N.R.R. Sec. 19 Survey, Abstract 327 and the north line of the C.H. Rushing Survey, Abstract 814 and being S60°53'15"E 54.62 feet from a found concrete monument for an angle corner of the above mentioned called 339.362 acre tract; REFERENCE: S60°53'15"E 25.4 feet to a set 1/2" iron rod.

THENCE S60°53'15"E 1738.56 feet along the line of directional control and the above mentioned common survey line to a found 1/2" iron rod for the northeast corner of this tract also being the northwest corner of a called 29.000 acre tract described by deed recorded in Volume 1004, Page 569;

THENCE S30°00'58"W 1521.13 feet to a found 1/2" iron rod for the southeast corner of this tract and also being the southwest corner of the above mentioned 29.000 acre tract located in the east R.O.W. of Old Highway 287;

THENCE along said R.O.W. as follows: N10°45'45"W 205.85 feet to a point, N12°22'05"W 446.96 feet to a point, N14°23'20"W 305.96 feet to a point, N22°46'42"W 306.17 feet to a point, N31°05'33"W 305.35 feet to a point, N31°46'31"W 209.42 feet to a point, N33°44'07"W 499.09 feet to a point at the intersection of said R.O.W. and the centerline of Forest Road 501 for the southwest corner of this tract;
