



THENCE N 45°00'00" W, 314.00', departing the northwest ROW line of said Grunwald Road and along the common Southwest line of herein described Tract and the northeast line of said called 4.828 acre tract conveyed to Richard S. Neuman, et ux, to a found 5/8" iron rod for the common West corner of herein described Tract and an exterior corner of a called 61.287 acre tract conveyed to Dennis Krause, Jr. and Denise A. Guest, recorded in C.C.F. No. 2003042033, O.P.R.F.B.C.T.;

THENCE N 45°00'00" E, 277.45', along the common Northwest line of herein described Tract and a southeast line of said called 61.287 acre tract conveyed to Dennis Krause, Jr. and Denise A. Guest, to a point for the common North corner of herein described Tract and an interior corner of said called 61.287 acre tract conveyed to Dennis Krause, Jr. and Denise A. Guest;
