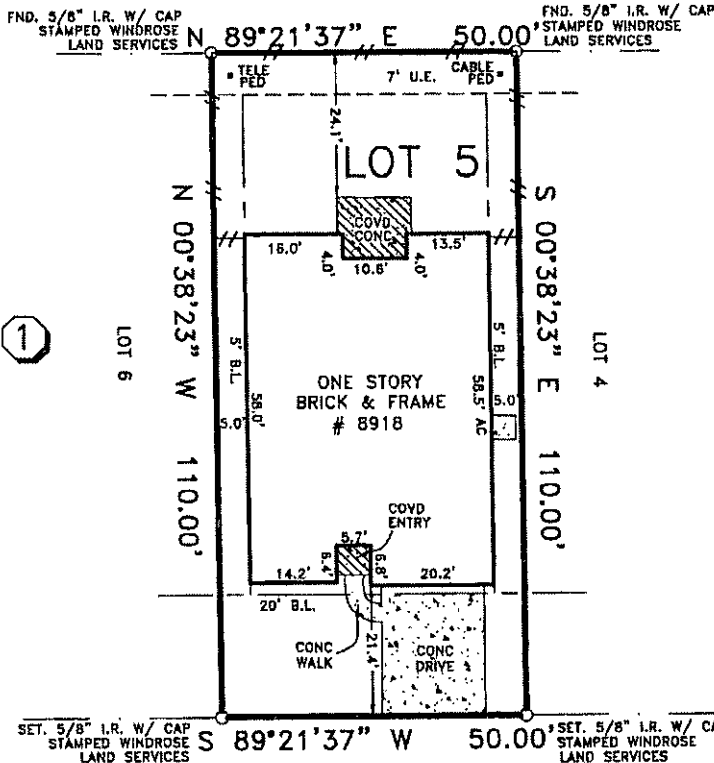


RESIDUE OF CALLED 29.519 ACRES
