Page 2 of 6, Section 2:

2021: After replacing drain lines under the house and backfilling, *Allied Foundation* placed 3 piers at front of house where access point had been. *Allied Foundation* accidentally cracked the brick façade when tensioning a pier. The crack has been pointed and repainted.

Page 2 of 6, Section 3:

2014: Upon closing on the house, *Houston Foundation Repair* placed 7 piers at front of house, along primary bath wall.

2021: To prevent future issues and preventively support the foundation, *Allied Foundation* placed 3 piers at front of house and 3 piers on the left side of house at and near excavation access points.

Page 4 of 6, Section 8:

2019: Mold from an improperly installed toilet upstairs caused mold to grow in the subfloor beneath the toilet and ceiling below. Subfloor was removed, ceilings in pantry and wine closet were removed, and walls in tub room and both adjacent bedrooms were removed. Mold was successfully remediated. Upon results of a mold inspection and tests (air samples and surface swabs), a Certificate of Mold Damage Remediation ("CMDR") was issued by a state licensed Mold Assessment Consultant (*Reliant Mold Testing & Inspections*) and a state licensed Mold Remediation Contractor (*United Water Restoration Group of Houston*) on June 18, 2019. Homeowners insurance covered the entire cost of remediation and reconstruction. At the completion of reconstruction, the flange was properly anchored using flange bolts and the toilet properly reinstalled by *Doug Turner Plumbing*.

2022: A state licensed Mold Assessment Consultant (*Mold Inspection & Testing Houston TX ("MI&T")*, see inspection report) performed three separate air samples (one control, one downstairs at the center of the house, and one in front upstairs bedroom) on February 17, 2022. There were no elevated levels of mold in the house (see sample reports by *SEEML Labs*).
