WORMAN, not joined herein by our wives as the hereinafter described property does not now and has never constituted a part of our homestead, hereinafter called Grantors, for and in consideration of the sum of TEN AND NO/100 (\$10.00) DOLLARS, and other good and valuable consideration paid by the Grantee herein named, the receipt of which is hereby acknowledged and confessed, have GRANTED, SOLD AND CONVEYED and by these presents do hereby GRANT, SELL AND CONVEY, subject to the reservations, restrictions, conditions and provisions herein set forth, unto NORTH WOODS RESORT, INC., a Texas corporation, its successors and assigns, the surface estate in and to that certain parcel of land containing 116.180 acres, more or less, situated in the Martin B. Lawrence Survey, A-310, Montgomery County, Texas, described in Exhibit "A" attached hereto, made a part hereof and incorporated herein for all purposes.

This conveyance is made and accepted subject to:

- (a) The exception and reservation by Grantors' predecessors of all oil, gas and other minerals in, or or under and that may be produced from the land conveyed hereby.
- (b) All valid and subsisting easements and rights of way for electric power, telephone and general utility purposes.
- (c) Any valid and subsisting easement and right of way resulting from the existing roadway traversing the most southerly southwest corner of the land conveyed hereby.
- (d) The rights of lessees under any valid or subsisting oil, gas and mineral leases currently in effect with respect to the land described in Exhibit "A" attached hereto.
- (e) The restrictions that for a period of twenty-five (25) years from June 30, 1977, no garbage dump or disposal area shall be located or permitted on the land and no commercial gravel mining or excavation area shall be opened or permitted thereon, which restrictions shall constitute covenants running, with the land.
