FIRST AMENDMENT

WHEREAS, at a meeting of the members of the Association duly called and held, the amendment below described was approved by more than a majority of the members of the Association; and

WHEREAS, Developer is the fee simple owner of several lots which are the subject of said Declaration and joins herein to approve said amendment;

NOW, THEREFORE, for and in consideration of the mutual covenants herein, and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Declaration is amended as follows:

- 1. Section 11(e) of the Declaration is hereby deleted and in its place the following is substituted:
 - (e) Bulkheads. The maintenance of the bulkhead immediately adjacent to any lot shall be the responsibility of the owner of such lot.
- 2. Any capitalized term not defined herein shall have the meaning ascribed to it in the Declaration. If there is any inconsistency or conflict between the provisions of this Amendment and the Declaration, the provisions of this Amendment shall control.
- 3. This Amendment will be governed by the laws of the State of Texas.
