BEGINNING at the northeast corner of said Cohen tract, same being the northwest corner of a called 0.123 acre tract as described in a Deed from Don C. Mathews to Merritt E. Jones, dated October 14, 1999 and recorded in Volume 403, Page 190, Official Records, found a 3/4" iron pipe in the called south line of 7th Street and being approximately 37.5 feet south of the center of the existing asphalt pavement of said street;

THENCE SO0°12'00"E (Jones deed call), with the east line of said Cohen tract and the west line of said Jones tract and also the west line of the residue of a tract or parcel of land as described in a Deed from the American Bank of Huntsville to Don C. Mathews, dated September 13, 1990 and recorded in Volume 128, Page 563, Official Records, for a total distance of 198.36 feet to the southeast corner of said Cohen tract, same being the southwest corner of said Mathews tract and also being the north line of a tract or parcel of land as described in a Deed from the Estate of E. M. Smither, et al to the Estate of Gabe Smither, et al, dated April 12, 1939 and recorded in Volume 91, Page 628, Deed Records, found a 3/4" iron pipe;

THENCE S89°08'30"W, with the south line of said Cohen tract and the north line of said Smither tract and also with the north line of a tract or parcel of land as described in the "Third Tract" in a Deed from Mary A. Smither, et al to the Gabe Smither Estate, dated December 31 1938 and recorded in Volume 110, Page 241, Deed Records, for a distance of 34.11 feet to the most southerly southwest corner of said Cohen tract, same being a southeasterly corner of a tract or parcel of land as described in a Deed from the Huntsville Building and Material Company to Walker County, Texas, dated September 11, 1989 and recorded in Volume 110, Page 726, Official Records, set a 5/8" iron rod;

THENCE, with the common lines of said Cohen and Walker County tracts, the following calls:

(1). N00°09'30"W - 35.00 feet to a 5/8" iron rod, set for corner; and (2). S89°08'30"W - 55.00 feet to the most westerly southwest corner of said Cohen tract, same being a northwesterly corner of said Walker County tract and also being the east line of a tract or parcel of land as described in a Deed from Gilbert W. Smith, et al to the County of Walker, dated October 29, 1990 and recorded in Volume 131, Page 397, Official Records, set a 5/8" iron rod;

THENCE NOO°09'30"W, with the west line of said Cohen tract and the east line of said County of Walker tract, for a distance of 164.93 feet to the northwest corner of said Cohen tract, same being the northeast corner of said County of Walker tract and also being the called south line of said 7th Street, found a 1/2" iron rod;

THENCE S89°50'30"E, with the north line of said Cohen tract and the called south line of said street, for a distance of 88.97 feet to the PLACE OF BEGINNING.
