

- The name of the corporation is Brazos Country Owners Association, Inc. 1.
- The following amendment to the Articles of Incorporation were adopted by the 2. affirmative vote of at least two-thirds of the members of Brazos Country Owners Association, Inc., present in person or by proxy, at the February 18, 1998 Special Meeting of the Members at which a quorum was present.

Article Six is amended to read as follows:

#### ARTICLE SIX **VOTING RIGHTS**

The corporation shall have one class of voting membership. All Owners shall be entitled to one vote for each Lot owned; provided, however, Lots which have been combined as provided in the Restrictions, shall be treated as a single Lot and entitled to one vote per combined Lot. 



The undersigned submits these articles pursuant to Texas Civil Statutes, Article 1302-7.01, to correct a document which is an inaccurate record of the entity action, contains an inaccurate or erroneous statement, or was defectively or erroneously executed, sealed, acknowledged, or verified.

#### ARTICLE ONE

The name of the entity is BRAZOS COUNTRY OWNERS ASSOCIATION, INC. (the "Corporation").

#### ARTICLE TWO

The document to be corrected is the "Articles of Incorporation of Brazos Country Owners Association, Inc.", which was filed in the Office of the Secretary of State on the 19th day of December, 1995.

#### ARTICLE THREE

The inaccuracy, error, or defect to be corrected are typographical and clerical errors in Article Four, Section (1) of the Articles of Incorporation when the filing references for the Restrictions for Section Five were inadvertently omitted and the reference to "Brazos Country, Section V" should be "Brazos Country, Section Five".

#### ARTICLE FOUR

As corrected, Article Four, Section (1) of the "Articles of Incorporation of Brazos Country Owners Association, Inc." should be changed to read as follows:

# ARTICLE FOUR PURPOSES

The purpose for which the corporation is organized are as follows:

# ARTICLES OF INCORPORATION of

I, the undersigned natural persons of the age of eighteen (18) years or more, acting as incorporator of a corporation under the Texas Non-Profit Corporation Act, do hereby adopt the following Articles of Incorporation for such corporation.

### ARTICLE ONE <u>NAME</u>

The name of the corporation is BRAZOS COUNTRY OWNERS ASSOCIATION, INC.

# ARTICLE TWO NON-PROFIT CORPORATION

The corporation is a non-profit corporation.

# ARTICLE THREE DURATION

The period of its duration is perpetual.

# ARTICLE FOUR PURPOSES

The purposes for which the corporation is organized are as follows:

operate, maintain, convey, sell, lease, transfer, dedicate for public use or otherwise dispose of real or personal property in connection with the affairs of the corporation;

- (c) borrow money, and with the mortgage, pledge, deed in trust, or hypothecate any or all of its real or personal property as security for money borrowed or debts incurred;
- (d) participate in mergers and consolidations with other nonprofit corporations organized for the same purposes; and
- (e) have and to exercise any and all powers, rights and privileges which a corporation organized under the Texas Non-Profit Corporation Act by law may now or hereafter have or exercise.
- (3) Notwithstanding any of the foregoing statements of purposes and powers:
  - (a) the corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the primary purpose of this corporation as set forth in Paragraph (1) of this Article Four;
  - (b) the corporation is organized pursuant to the Texas Non-Profit Corporation Act and does not contemplate pecuniary gain or profit to the members thereof and is organized for non-profit purposes; and
  - (c) IT SHALL NOT BE ONE OF THE PURPOSES OF THE CORPORATION TO PROVIDE SECURITY TO THE RESIDENTS OF THE PROPERTY. NEITHER THE CORPORATION, ITS BOARD, NOR ITS OFFICERS OR DIRECTORS SHALL, IN ANY WAY, BE CONSIDERED INSURERS OR GUARANTORS OF SECURITY WITHIN THE PROPERTY AND SHALL NOT BE HELD LIABLE FOR ANY LOSS OR DAMAGE BY REASON OR ALLEGED FAILURE TO PROVIDE ADEQUATE SECURITY OR INEFFECTIVENESS OF SECURITY MEASURES UNDERTAKEN, IF ANY.

# ARTICLE FIVE MEMBERSHIP

Every owner of a Lot in the Property shall be a member of the Corporation. Membership shall be appurtenant to and may not be separated from ownership of any Lot in the Property, which is subject to assessment by the Corporation.

### ARTICLE SIX

### **VOTING RIGHTS**

The corporation shall have two classes of voting membership:

Class A. Class A members shall be all Owners, with the exception of Brazos Country Development Corporation, a Texas corporation (the "Dedicator"), and shall be entitled to one vote for each Lot owned; provided, however, Lots which have been combined as provided in the Restrictions, shall be treated as a single Lot and entitled to one vote per combined Lot. When more than one person shall be treated as a single Lot and entitled to one vote per combined Lot. When more than one person holds an interest in any Lot, all such persons shall be members. The vote for such Lot shall be exercised they determine, but in no event shall more than one vote be cast with respect to any Lot.

Class B. The Class B member(s) shall be the Dedicator and shall be entitled to three (3) votes for each Lot owned. The Class B membership shall cease and be converted to Class A membership on January 1, 2005.

Provided the provisions of Article 1396-9.10C of the Texas Non-Profit Corporation Act are fully complied with, any action required by the Texas Non-Profit Corporation Act to be taken at a meeting of directors or any committee of the corporation or any action that may be taken without a meeting if a consent in writing setting forth the action to be taken is signed by a sufficient number of directors or committee members as would be necessary to take that action at a meeting at which all of the directors or members of the committee were present and voted.
