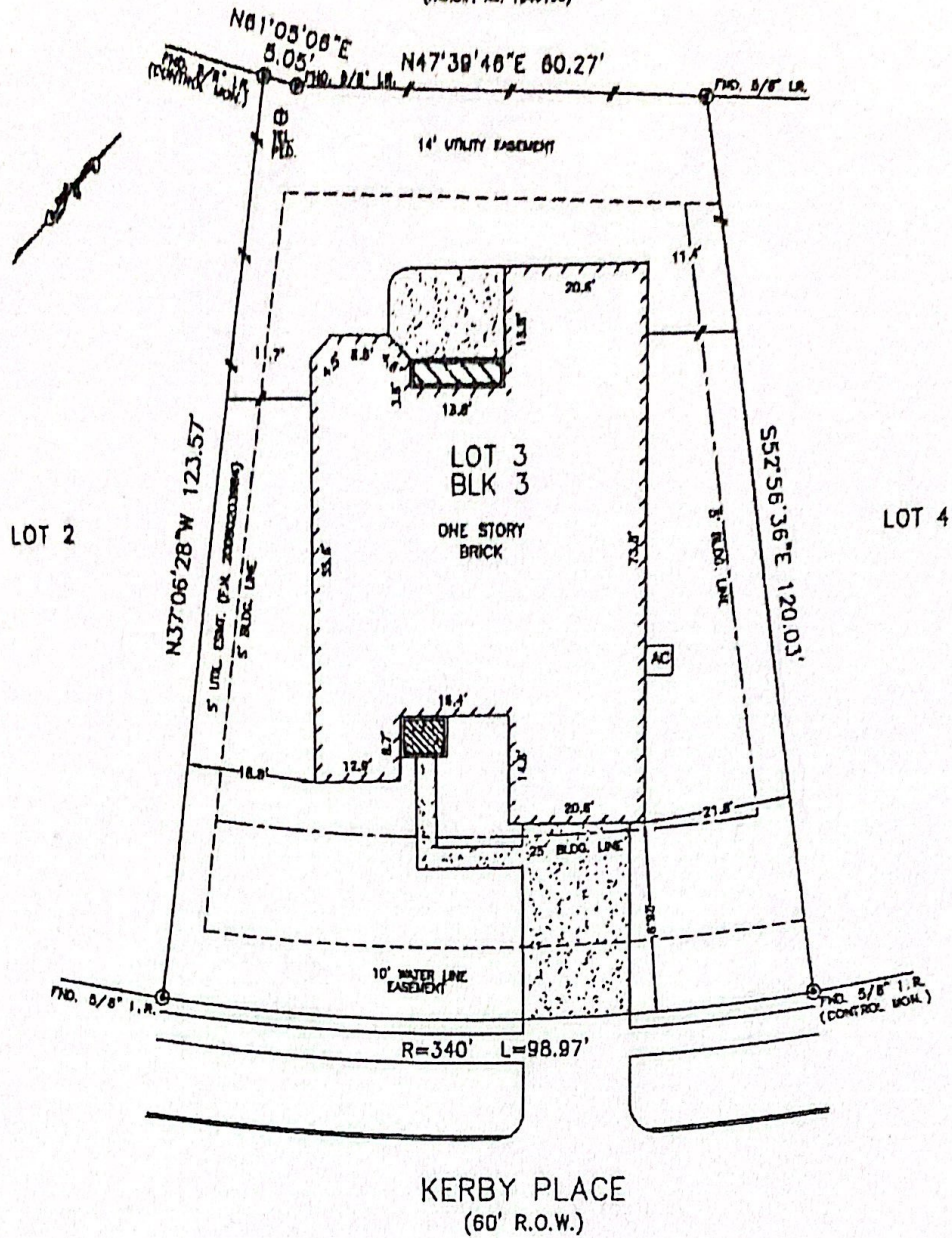


DETENTION EASEMENT

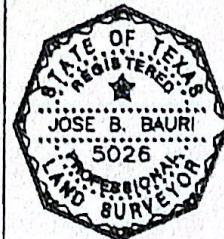
