**BEGINNING** at a point in the centerline of Chapman Road (60 foot right of way) marking the most southerly corner of a said Huang tract one (Lot 37), the most westerly corner of a called 1.00 acre tract of land described in deed to Euseblo Q. Famorca and Natividad A. Famorca recorded in Instrument No. 2012117374 O.P.R.F.B.C.,TX (Lot 36), the most northerly corner of a called 1.00 acre tract of land described in deed to Jaime and Estrellita P. Pasuquin recorded in Instrument No. 9867996 O.P.R.F.B.C.,TX (Lot 55) and the most easterly corner of a called 2.00 acre tract of land described in deed to Jaime and Estrellita P. Pasuquin recorded in Instrument No. 9867996 O.P.R.F.B.C.,TX (Lot 54) from which a set 5/8 inch iron rod with cap stamped "RPLS 6229" in the northeast right of way line of Chapman Road bears North 42 degrees 31 minutes 38 seconds East 30.00 feet;

**THENCE** with the centerline of Chapman Road, the southwest line of said Lot 37 and the northeast line of said 2.00 acre tract (Lot 53) **North 47 degrees 28 minutes 22 seconds West 114.11 feet** to a point in the centerline of Chapman Road marking the most westerly corner of said Huang tract one (Lot 37), and the most southerly corner of a called 1.00 acre tract of land known as Tract Two described in deed to Chiung Hua Huang and Lucita Huang recorded in Instrument No. 2012108072 O.P.R.F.B.C.,TX (Lot 38) from which a set 5/8 inch iron rod with cap stamped "RPLS 6229" in the northeast right of way line of Chapman Road bears North 42 degrees 32 minutes 11 seconds East 30.00 feet;

**THENCE** with the southeast line of said Huang tract two (Lot 38) and the northwest line of said Huang tract one (Lot 37) **North 42 degrees 32 minutes 11 seconds East 381.75 feet** to a found 1/2 inch iron pipe marking the most northerly corner of said Huang tract one (Lot 37), the most easterly corner of said Huang tract two (Lot 38) and the most westerly corner of a called 1.00 acre tract of land described in deed to Jose Antonio Compean and Grecia Delmis Alzate recorded in Instrument No. 2013026201 O.P.R.F.B.C.,TX (Lot 19) and the most southerly corner of a called 1.00 acre tract of land described in deed to Wilmer Elenilson Serrano and Jennifer Serrano recorded in Instrument No. 2013026203 O.P.R.F.B.C.,TX (Lot 18);

**THENCE** with the southeast line of said Huang tract two (Lot 38), and the northwest line of said Huang tract one (Lot 37), **South 42 degrees 32 minutes 11 seconds West** at 351.75 feet **passing** a set 5/8" iron rod with cap stamped "RPLS 6229" in the northeast right of way line of Chapman Road and continuing in all **a total distance of 381.75 feet** to a point in the centerline of Chapman Road and the north line of said 2.00 acre tract marking the most southerly corner of said Huang tract two (Lot 38), and the most westerly corner of said Huang tract one (Lot 37);
