

BEGINNING on a inch iron rod found for the South West corner of this lot and being in the South line of the said original Lot 3, of the said Turner Terrace Subdivision, and being in the North line of Lazy Lane and being S 87° 50° 00" W 1.40 feet from found "X" marked in concrete drive for the South East corner of Lot 3, and the South West corner of the said original Lot 4;


THENCE N 1° 30' 58" W 173.66 feet to a ½ inch iron rod set for corner, same being the North East corner of said Lot 3, and the North West corner of Lot 4, and being in the South East line of Mrs. V.E. Murray called 1.0 acre tract recorded in Vol. 104, Page 347 of the Deed of Trust records;

THENCE N 62° 39' 06" E 67.0 feet to a 1/2 inch iron rod set for the North East corner of said Lot 4, and the North West corner of said Lot 5, Larry Davis lot recorded in Vol. 679, Page 253 of the H.C.D.R. and also being in the South East line of the said Murray lot;

THENCE S 4° 20' 28" E 202.30 feet along with and near a boundary line agreement signed and dated April 4, 1975, recorded in Vol. 545, Page 535 of the H.C.D.R., to a 3/4 inch iron pipe and ½ inch iron rod found for corner in the North line of the said Lazy Lane and being in the South line of said Lot 5;

THENCE S 87° 50' 00" W 70.27 feet to the place of beginning and containing 0.283 acre of land more or less.
