AMENDMENT TO RESERVATIONS, RESTRICTIONS AND COVENANTS OF LOCH-NESS COVE

WHEREAS, a certain tract of land described on Exhibit "A", which is attached hereto and incorporated herein by reference, has been platted into a certain subdivision known as LOCH NESS COVE according to the plat of said subdivision recorded in the office of the County Clerk of Montgomery County, Texas, on November 13, 1972, after having been approved as provided by law and being recorded in Volume 10, Page 57, of the Map Records of Montgomery County, Texas and

WHEREAS, certain reservations, restrictions and covenants were adopted, established, promulgated and impressed upon the said land described in Exhibit "A", containing, among other provisions, the following:

"All lots in the subdivision shall be used only for single family residential purposes. . . no house trailer, camper trailer, camper vehicle, or motor vehicle (or portion thereof) or any mobile type home or movable prefabricated home shall be lived in on any lot. . .

No structure of a temporary character, trailer, basement, tent, shack, garage, barn or other out building shall be used on any lot at any time as a residence. . ." and

WHEREAS, the Developer, LOCH NESS, INC., a Texas Corporation, has recommended the amendment and modification of the said reservations, restrictions and covenants as heretofore set out, and

WHEREAS, all of the lot owners in LOCH NESS COVE have been given thirty (30) days notice in writing of the proposed amendment of same, and

WHEREAS, upon vote of all of the lot owners of the LOCH NESS COVE subdivision, the following undersigned persons, who constitute more than two-thirds (2/3) of the lot owners in the said LOCH NESS COVE subdivision, have agreed to modify the said reservations, restrictions and covenants, therefore,

The reservations, restrictions and covenants of LOCH NESS COVE subdivision are hereby amended and modified by recommendation of LOCH NESS, INC., a Texas Corporation, the Developer and ratified by the undersigned vote of two-thirds (2/3) of the lot owners in the said subdivision as follows:

"The following reservation, restriction and covenant shall hereafter be applicable to the land of LOCH NESS COVE, a subdivision recorded in the office of the County Clerk of Montgomery County, Texas, on November 13, 1972, after having been approved as provided by law, and being recorded in Volume 10, Page 57 of the Map Records of Montgomery County, Texas, as well as any other filings in the Official Public Records of Real Property of Montgomery County, Texas.

Notwithstanding any reservations, restrictions and covenants to the contrary herein contained, the terms "house trailer", "camper trailer", "camper vehicle", "mobile type home", "movable prefabricated home", "home of a temporary character", and "trailer" shall

not be construed to prevent an owner from using for residential purposes a multi-section manufactured home constructed to building codes approved by the State of Texas or Federal Government and which are placed on any lot or lots with a lawfully approved foundation system. A multi-section manufactured home means a dwelling that is manufactured or prefabricated in two or more modules at a location other than the lot in the subdivision and which is designed to be used as a residence when the modules are transported to the lot and the modules are joined together and installed in accordance with applicable governmental codes regarding the foundation system. The term includes the plumbing, heating, air conditioning and electrical systems contained in the structure. However, it is provided that any such multi-section home must have been manufactured within four (4) years from the date that such structure is desired to be placed on a lot or lots by an owner.
