b. changes in the location of boundary fences or boundary walls;
c. construction projects on immediately adjoining property(ies) which encroach on the Property;
d. conveyances, replattings, easement grants and/or easement dedications (such as a utility line) by any party affecting the Property.

EXCEPT for the following (If None, Insert "None" Below:) Property owners of home located at 4319 Estes Ridge Lane constructed a swimming pool on October, 2020, and removed part of fence along north boundary and replaced it at the completion of construction.

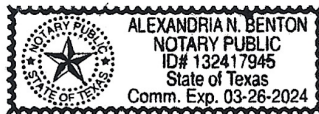
