ADDENDUM TO RESIDENTIAL LEASE CONCERNING THE PROPERTY AT 12735 Corona Ln, Houston, TX 77072

Α.	LEAD WARNING STATEMENT: Housing built before 1978 may contain lead-based paint. Lead from paint, paint chips, and dust can pose health hazards if not managed properly. Lead exposure is especially harmful to young children and pregnant women.
