**BEING** 1.407 acres situated in the Samuel P Jones Survey, Abstract 516, being all of a called 1.404 acres as recorded in Instrument #20190100012589 of the Official Public Records of Smith County, Texas (OPRSCT) being located at 19574 County Road 2176 (CR 2176), Whitehouse, Texas and more particularly described by metes and bounds as follows:

**BEGINNING** at an existing ½" iron rod found marking the Southwest corner of this tract, the Northwest corner of a called 1.599 acres as recorded in Instrument # 20100100031128 of the OPRSCT, and being in the East line of a called 20.780 acres as recorded in Instrument #20190100007453 of the OPRSCT;

**THENCE** with the east line of said called 20.780 acres North 01°51'11" West a distance of 143.84 feet to a an existing ½" iron rod found in same and marking the Southwest corner of a called 1.385 acres as recorded in Instrument #20150100025555 of the OPRSCT;

**THENCE** with South line of said called 1.385 acres North 80°03'12" East a distance of 435.75 feet to a ½" iron rod w/cap (RPLS #5980) set marking the Southeast corner of same and being in the West margin of County Road 2176(CR 2176);

**THENCE** with the west margin of said CR 2176 and a curve to the left with a Radius of 2149.16 feet, an arc length of 55.66 feet, a chord length of 55.66 feet, a chord bearing of South 13°09'09" East, and a delta angle of 1°29'02" to a ½" iron rod w/cap (RPLS #5980) set in same and being the point of beginning to a curve to the right;

**THENCE** with said curve to the right and West margin of said CR 2176 with a radius of 2149.16 feet, an arc length of 75.04 feet, a chord length of 75.04 feet, a chord bearing of South 12°53'39" East, and a delta angle of 2°00'02" to an existing ½" iron rod found in same, and marking the Northeast corner of said called 1.599 acres;

**THENCE** with the North line of said called 1.599 acres South 78°34'54" West a distance of 463.13 feet to the place of beginning and containing 1.407 acres.

Note: Bearings are based on the Texas State Plane Coordinate System, Texas North Central, Zone 4202, NAD 83.
