Fort Bend County, Texas Tract 10: 11.12 Acres Project No. 21-282

METES AND BOUNDS DESCRIPTION OF TRACT 10 BEING A 11.12 ACRE TRACT OF LAND OUT OF AND PART OF A CALLED 104 ACRE TRACT OF LAND (SURVEYED THIS DAY AS 104.24 ACRES) KNOWN AS THE SOUTHEAST 1/3 OF A 320 ACRE TRACT LESS 8 ACRES FOR HIGHWAY PURPOSES DESCRIBED IN DEED TO GERALD PARKER, TRUSTEE OF THE ZIPP MANAGEMENT TRUST RECORDED IN INSTRUMENT NO. 2018005701 OF THE OFFICIAL PUBLIC RECORDS OF FORT BEND COUNTY, TEXAS (O.P.R.F.B.C.,TX) AND SITUATED IN THE H&TC RR CO SURVEY SECTION 113, ABSTRACT NO. 257 OF FORT BEND COUNTY, TEXAS. SAID 11.12 TRACT BEING MORE PARTICULARLY DESCRIBED BY METES AND BOUNDS AS FOLLOWS:

BEGINNING at a set 5/8 inch iron rod with cap stamped "RPLS 6229" in the northwest right of way line of Beard Road (80 foot right of way) and the southwest line of a called 633.17 acre tract of land described in deed to S.A. Beard recorded in Volume 390, Page 419 of the Deed Records Fort Bend County, Texas marking the most easterly corner of said 104 acre tract and the most easterly corner of said Tract 10;

THENCE with the southeast line of said Tract 10, the southeast line of said 104 acre tract and the northwest line of Beard Road **South 41 degrees 46 minutes 38 seconds West 558.55 feet** to a set 5/8 inch iron rod with cap stamped "RPLS 6229" marking the most easterly corner of Tract 9 this day surveyed being 11.12 acres and the most southerly corner of said Tract 10;

THENCE on, over and across said 104 acre tract, with the northeast line of said Tract 9 and the southwest line of said Tract 10 **North 48 degrees 13 minutes 22 seconds West 864.28 feet** to a set 5/8 inch iron rod with cap stamped "RPLS 6229" in the northwest line of said 104 acre tract and in the southeast line of a called 104.405 acre tract of land described in deed to Saira Meena and Syed Masood recorded in Instrument No. 2015145395 O.P.R.F.B.C.,TX marking the most westerly corner of said Tract 10 and the most northerly corner of said Tract 9 from which a found 1 inch iron pipe marking the most westerly corner of said 104 acre tract bears South 41 degrees 48 minutes 55 seconds West 4,684.19 feet;

THENCE with the southeast line of said 104.405 acre tract, the northwest line of said 104 acre tract and the northwest line of said Tract 10 **North 41 degrees 48 minutes 55 seconds East 562.85 feet** to a set 5/8 inch iron rod with cap stamped "RPLS 6229" in the southwest line of said 633.17 acre tract marking the most easterly corner of said 104.405 acre tract, the most northerly corner of said 104 acre tract and the most northerly corner of said Tract 10;

THENCE with the northeast line of said 104 acre tract, the southwest line of said 633.17 acre tract and the northeast line of said Tract 10 **South 47 degrees 56 minutes 15 seconds East 863.91 feet** to the **POINT OF BEGINNING** of the herein described tract and containing 11.12 acres within these metes and bounds.
