In addition to the above described reservation, there is hereby excepted from the conveyance of the above described tract of land and the same made subject to, all those reservations, restrictions, covenants, easements, dedications and agreements as recorded in Volume 602, Page 162 of the Deed Records of County Clerk of Montgomery County, Texas.

As a covenant running with the land, it is expressly agreed by the Grantees hereto that for the purpose of maintaining, repairing and improving such parks, lakes and roads that the Grantees agree to pay to WOODLAND LAKES CIVIC CLUB, a maintenance fee of Three Dollars (\$3.00) per month per lot (or such other additional fees that may be prescribed by the Board of Directors of said CIVIC CLUB as necessary to defray any unforseen costs that may be incurred in the future); which charge shall constitute a first and superior line upon the lot upon which charge is imposed; provided, however, that each such lien shall be specifically made secondary, subordinate and inferior to or in the instance and request of the owner of any such lot to secure the payment of monies advanced or to be advanced on such lot and provided that as a condition precedent to any proceeding to enforce such lien upon any lot upon which there is a line, the beneficiary shall give the holder of such first mortgage lien sixty (60) days written notice to such proposed action.
