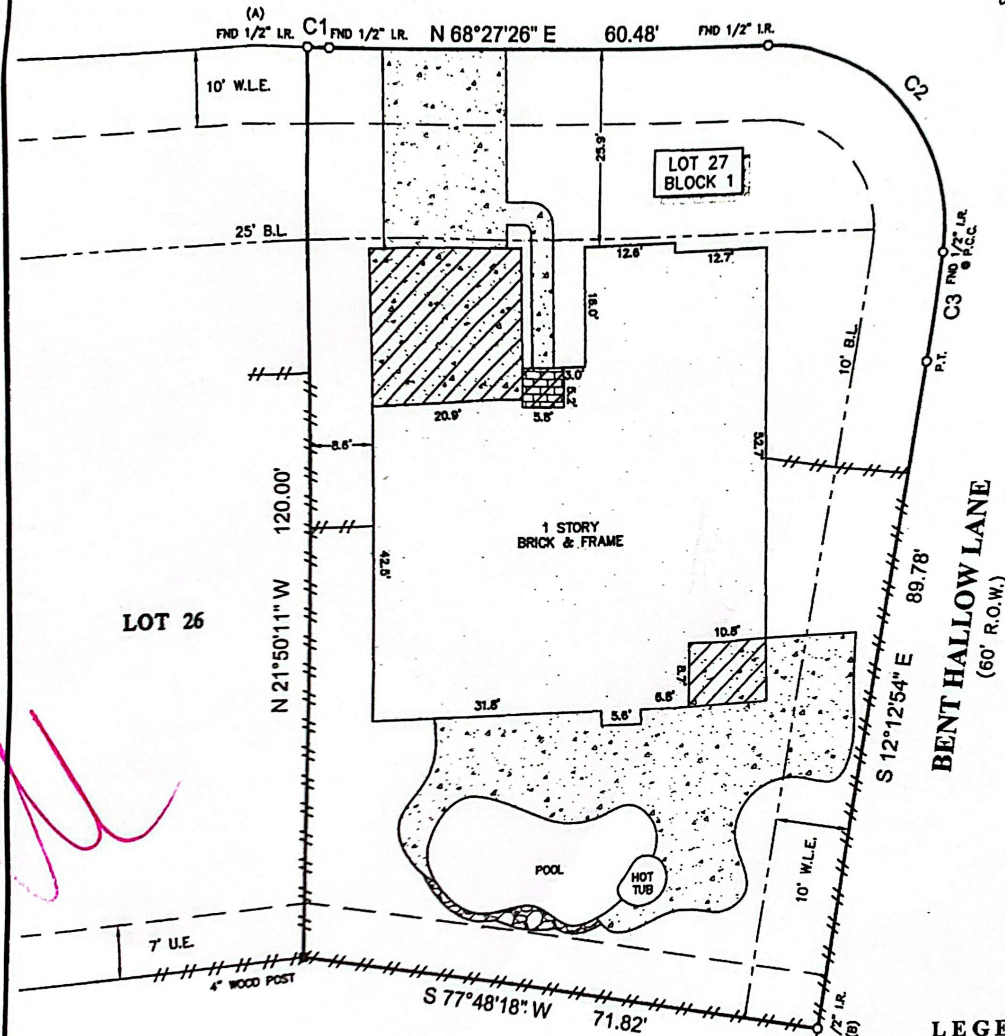

WINDING RUN LANE (50' R.O.W.)



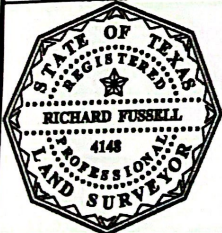
