

We, the undersigned natural persons of the age of eighteen (18) years or more, at Weast two (2) of whom are citizens of the State of Texas, acting as incorporators of a corporation (hereinafter called the "Corporation") under the Texas Non-Profit Corporation Act (hereinafter called the "Act") do hereby adopt the following Articles of Incorporation for such Corporation.

ARTICLE 1

NAME

The name of the Corporation is REGENCY COURT HOMEOWNERS ASSOCIATION, INC.

ARTICLE II

NON-PROFIT COMPORATION

The Corporation is a non-profit corporation.

ARTICLE ITI

DURATION

The period of the duration of the Corporation is perpetual.

ARTICLE IV

PURPOSES AND POWERS

1. The Corporation does not contemplate pecuniary gain or profit to the Hembers thereof, and its specific and primary purpose is to provide for the preservation and maintenance of a Condominium Project, as provided in the Condominium Declaration of RECENCY COURT TOWNHOME CONDOMINIUMS (hereinafter referred to as the full "Declaration"), located in Harris County, Texas.

2. The general purposes and powers are:

- a. To promote the cummon good, health, safety and general welfare for the residents within the Property;
- b. To exercise all of the powers and privileges and to perform

The Corporation is one which does not contemplate pecuniary gain or profit to the Members thereof, and it is organized solely for non-profit purposes. In the event of liquidation, dissolution or winding up of the Corporation, whether voluntarily or involuntarily, the Directors shall dispose of the Property and assets of the Corporation in such manner as they, in the exercise of their discretion (as set out in the Declaration), deem appropriate; provided, however, that such disposition shall be exclusively in the furtherance of the object and purposes for which the Corporation or any individual having a personal or private interest in the affairs of the Corporation or any organization which engages in any activity in which the Corporation is precluded from engaging.
