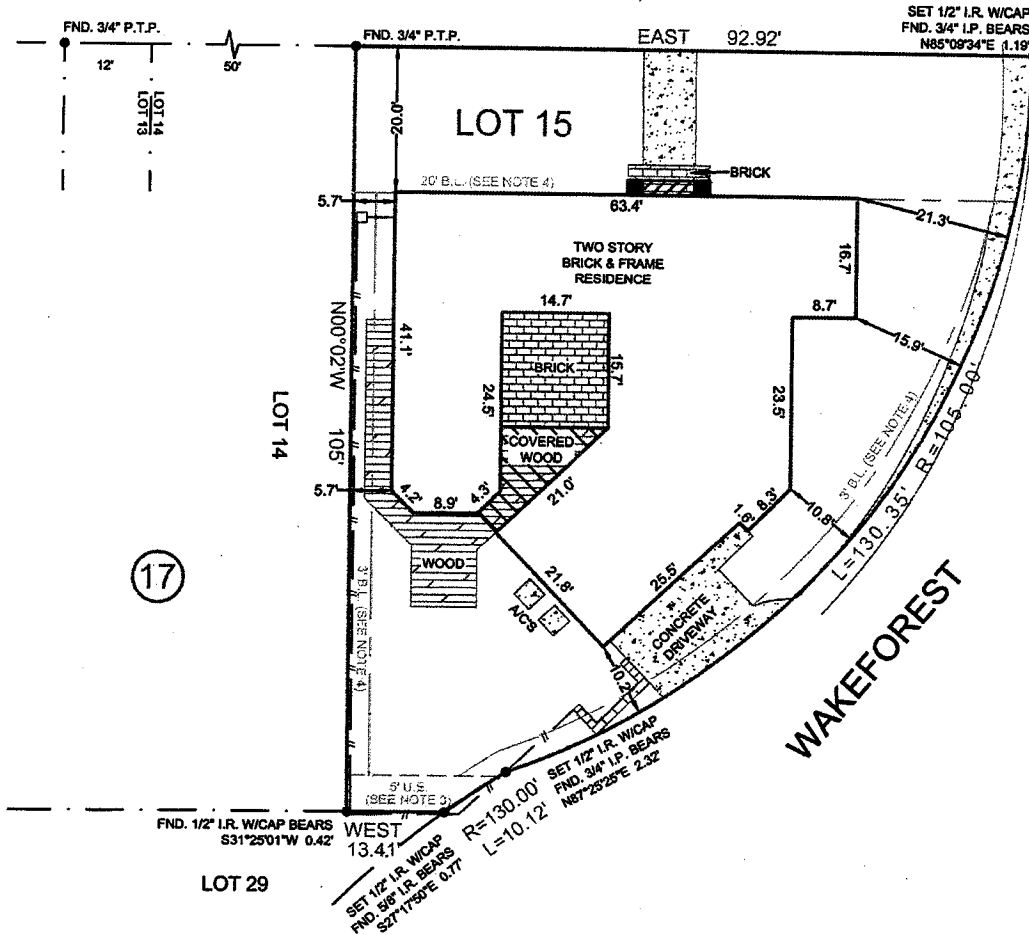


TANGLEY ST

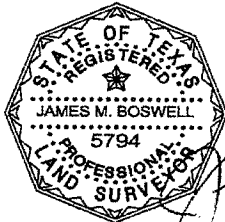
