METES AND BOUNDS DESCRIPTION

Being a tract of land containing 5.249 acres, in the Samuel H. Williams Survey, A-62, in Burleson County, Texas, as recorded in Vol. 1130, Page 346 of the Burleson County Official Records (B.C.O.R.). All bearings of this survey are referenced to the Texas State Plane Coordinate System, Central Zone, NAD83(2011) Epoch 2010, and boundary referenced to 1/2" iron rods found and referred to the previous recorded deed, as surveyed on the ground on November 5th of 2019. This description is also referred to the plat prepared by ATM Surveying, Project No. 2019-0419, and being more particularly described as follows:

BEGINNING at a 1/2" iron rod with red plastic cap marked "RPLS-2547" found for the north corner of this tract, also being an east corner of the Darren Keith Broesche called 71.62 acre tract, as recorded in Vol. 482, Page 603 of the B.C.O.R., also being a point in the southwest right-of-way line of FM 60 South (100' R.O.W.);

THENCE South 46°51'44" East, a distance of 207.72 feet along the common line between this tract and said FM 60 South to a 1/2" iron rod found for the east corner of this tract, also being the north corner of the Darren Keith and Roger Alan Broesche called 100.50 acre tract, as recorded in the deed number 2019 – 4002 of the B.C.O.R.;

THENCE South 41°35'18" West, a distance of 983.17 feet along the common line between this tract and said 100.50 acre tract to a 1/2" iron rod with maroon plastic cap marked "RPLS 6132 - ATM SURV" set for the south corner of this tract, also being an east corner of the said 71.62 acre tract, from which a 1/2" iron rod found leaning bears N 25°50'16" W, a distance of 2.07 feet for reference;


