Thence South 01 degrees 07 minutes 48 seconds East, 144.44 feet along the common line between said Guerrero tract and said Weishuhn tract to a 1/2" iron rod set for an angle point of a (called) six acre Rosezena Woodson tract (Vol. 120, Pg. 351 C.C.D.R.) (Deed) and being the Westerly six acres of a 16.6 acre tract (Vol. 91, Pg. 456 C.C.D.R.) (Desc.) for the Southerly Southwest corner of said Guerrero tract, the Southeast corner of said Weishuhn tract and the Southeast corner of the herein described tract, from which a 5/8" iron rod found at the base of a fence corner bears South 74 degrees 01 minutes 34 seconds West, 6.53 feet;


