THENCE, SOUTH 5° 23' 26" EAST, A DISTANCE OF 383.21 FEET TO A SET FIVE-EIGHT INCH IRON ROD FOR THE SOUTHEAST CORNER OF THE HEREIN DESCRIBED TRACT, FROM WHICH A FOUND HALF-INCH IRON ROD FOR THE SOUTHWEST CORNER OF SAID 23.59 ACRE TRACT BEARS SOUTH 5° 23' 26" EAST, A DISTANCE OF 723.13 FEET;

THENCE ALONG SAID SURVEY LINE, NORTH 86° 48' 39" EAST, A DISTANCE OF 220.30 FEET TO A FOUND HALF-INCH IRON ROD;

THENCE, NORTH 86° 24' 57" EAST, A DISTANCE OF 1,148.82 FEET TO A FOUND HALF-INCH IRON ROD;

THENCE, NORTH 87° 17′ 51″ EAST, A DISTANCE OF 544.78 FEET TO A MAG IN ASHALT FOR THE NORTHEAST CORNER OF THE HEREIN DESCRIBED TRACT AND NORTHWEST CORNER OF SAID 0.8938 ACRE TRACT;
