Active infestation of termites or other wood destroying insects (WDI) – Active infestation of termites was discovered on the front porch columns. This area and the entire house were treated 2-10-23, and given a year warranty.

"500-year floodplain" means any area of land that: (A) is identified on the flood insurance rate map as a moderate flood hazard area, which is designated on the map as Zone X (shaded); and (B) has a two-tenths of one percent annual chance of flooding, which is considered to be a moderate risk of flooding.
