Lots 89, 90 and 91:

BEGINNING at a 1/2 Inch iron rod found on the south right-of-way line of Carol Lane, being the northeast corner of said Lot 91 and being the northeast corner of this tract (from which a second 1/2 Inch iron rod found bears North 89° 41' 00" East, a distance of 100.00 Feet, from said second 1/2 Inch iron rod found a third 1/2 Inch iron rod found bears North 89° 41' 00" East, a distance of 200.00 Feet);

THENCE, **SOUTH 00° 06' 00'' EAST**, with the west line of Lot 92, as recorded in the name of Starter Homes of Texas, LLC. under Document No. 2022080873 of the R.P.R.M.C.T., a distance of **163.00 Feet** to a 1/2 Inch iron rod found at the southeast corner of said Lot 91, being the southeast corner of this tract (from which a second 1/2 Inch iron rod found bears North 89° 41' 00'' East, a distance of 100.00 Feet):

THENCE, **SOUTH 89° 41' 00'' WEST**, with the north line of a tract recorded in the name of MCE Ventures, LLC. under Document No. 2011091526 of the R.P.R.M.C.T., passing at a distance of 200.00 Feet a point at the southeast corner of the aforementioned Lot 89 (from which a 5/8 Inch iron rod found bears North 10° 07' 26" West, a distance of 0.91 Feet), and continuing an additional distance of 100.00 Feet for a total distance of **300.00 Feet** to a point at the southwest corner of said Lot 89, being the southwest corner of this tract from which a 5/8 Inch iron rod found bears South 06° 31' 53" West, a distance of 1.25 Feet;

THENCE, **NORTH 00° 06' 00'' WEST**, with the east line of Lot 88, as recorded in the name of Fausto Martinez Quijada, and wife, Eva Martinez under Document No. 2006017992 of the R.P.R.M.C.T., a distance of **163.00 Feet** to a 1/2 Inch iron rod with a "Precision" cap set on the aforementioned south right-of-way line of Carol Lane at the northwest corner of said Lot 89 being the northwest corner of this tract;

THENCE, **NORTH 89° 41' 00'' EAST**, with said south right-of-way line, passing at a distance of 200.00 Feet a 1/2 Inch iron pipe found at the northeast corner of the aforementioned Lot 90, and continuing an additional distance of 100.00 Feet for a total distance of **300.00 Feet** to the POINT OF BEGINNING.

Lot 87:

COMMENCING at a 1/2 Inch iron rod found on the south right-of-way line of Carol Lane, being the northeast corner of Lot 91 (from which a second 1/2 Inch iron rod found bears North 89° 41' 00" East, a distance of 100.00 Feet, from said second 1/2 Inch iron rod found a third 1/2 Inch iron rod found bears North 89° 41' 00" East, a distance of 200.00 Feet);

THENCE, SOUTH 89° 41' 00" WEST, with said south right-of-way line, passing at a distance of 100.00 Feet a 1/2 Inch iron pipe found at the northeast corner of Lot 90, passing at an additional distance of 200.00 Feet a 1/2 Inch iron rod with a "Precision" cap set at the northwest corner of Lot 89 and continuing an additional distance of 100.00 Feet Feet for a total distance of 400.00 Feet to a 1/2 Inch iron rod with a "Precision" cap set at the northeast corner and POINT OF BEGINNING of this tract.

THENCE, **SOUTH 00° 06' 00'' EAST**, with the west line of Lot 88, as recorded in the name of Fausto Martinez Quijada, and wife, Eva Martinez under Document No. 2006017992 of the R.P.R.M.C.T., a distance of **163.00 Feet** to a 1/2 Inch iron rod with a "Precision" cap set at the southeast corner of this tract;

THENCE, **SOUTH 89° 41' 00'' WEST**, with the north line of a tract recorded in the name of MCE Ventures, LLC. under Document No. 2011091526 of the R.P.R.M.C.T., a distance of **100.00 Feet** to a 1/2 Inch iron rod with a "Precision" cap set at the southwest corner of this tract;

THENCE, **NORTH 00° 06' 00'' WEST**, with the east line of Lot 86, as recorded in the name of Jose G. Garcia and Maria C. Garcia under Document No. 2015016741 of the R.P.R.M.C.T., being further described in Volume 1096, Page 653 of the R.P.R.M.C.T., a distance of **163.00 Feet** to a 1/2 Inch iron rod with a "Precision" cap set on the aforementioned south right-of-way line of Carol Lane at the northwest corner of this tract;

THENCE, NORTH 89° 41' 00'' EAST, with said south right-of-way line, a distance of 100.00 Feet to the POINT OF BEGINNING.
