Thence, S 08°26'34" E, along the common line of said Lots 7 and 8, a distance of 188.89 feet to a 1/2" iron rod found on the common line of that certain called 0.74 acre tract of land being Lots 19 and 20, Block 2, of said Caney Colony, as conveyed to Marion Carl and Wife, Debra K. McWhirter by instrument recorded in Document No. 9883994 of the Official Public Records of Montgomery County, Texas, for the south common corner of said Lots 7 and 8, same being the southeast corner of the herein described tract;

Thence, S 84°57'59" W, in part along the common line of said 0.74 Acre Tract and that certain called 0.70 acre tract of land being Lots 21 and 22, Block 2, of said Caney Colony, as conveyed to Carl McWhirter and Wife, Debra McWhirter by instrument recorded in Document No. 2018037857 of the Official Public Records of Montgomery County, Texas, same being the common line of said Lots 7 and 6, a distance of 170.30 feet to a point for the south common corner of said Lot 6 and that certain called 0.344 acre tract of land being Lot 5, Block 3, of said Caney Colony, as conveyed to Carla Dubrena Rutowski by instrument recorded in Document No. 2010000428 of the Official Public Records of Montgomery County, Texas, same being the southwest corner of the herein described tract, from which a ¹/₂" iron rod found for reference bears, S 44°01'05" W, a distance of 3.32 feet;
