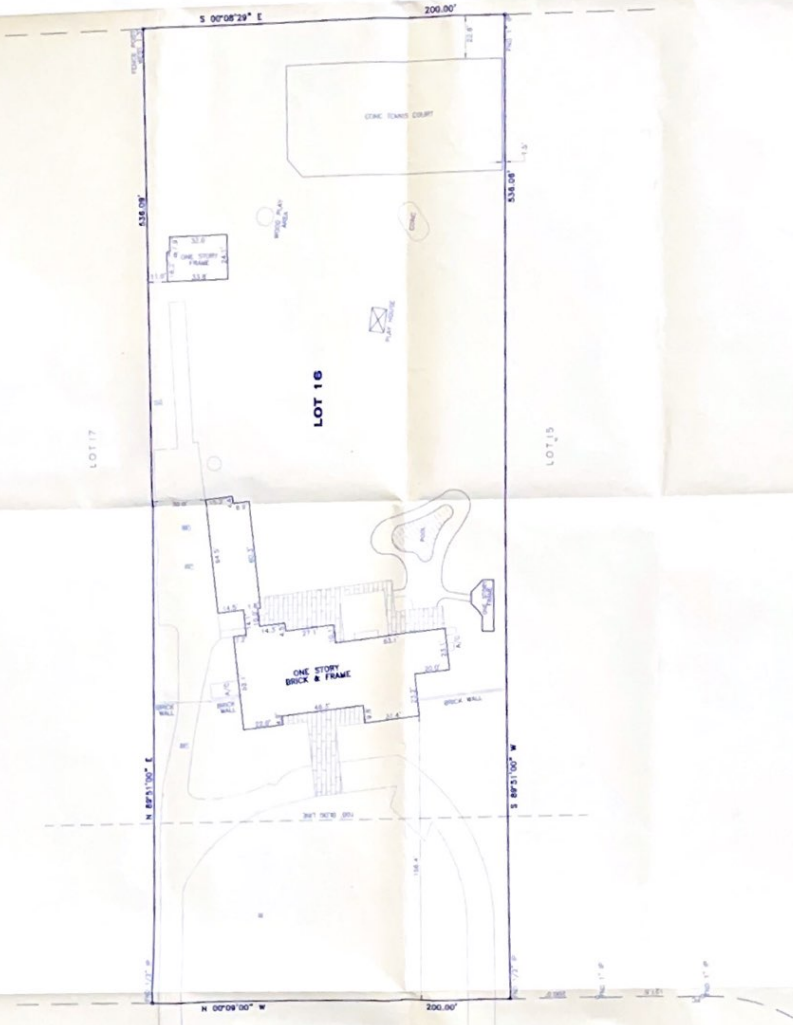




TIMBERWILDE LANE
