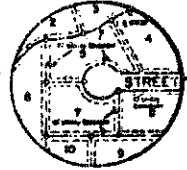


TYPICAL UTILITY EASEMENT



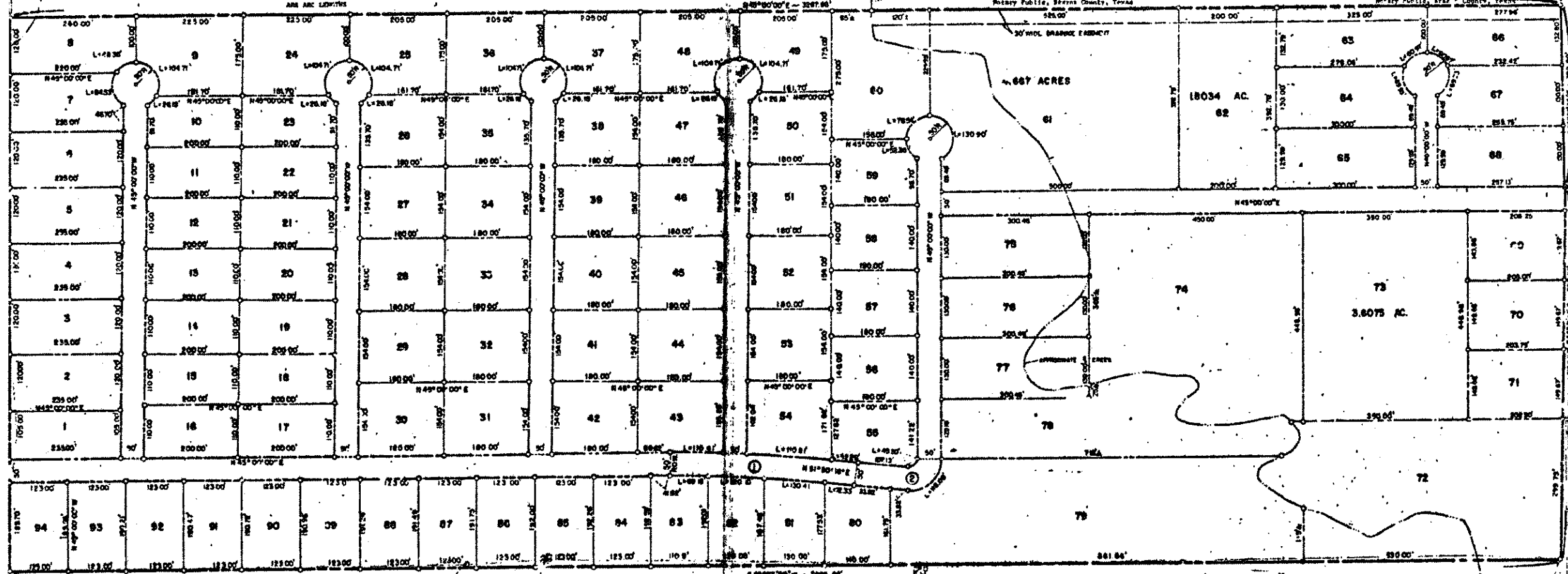
ADDITIONAL EASEMENT OR SERVICE PLAT

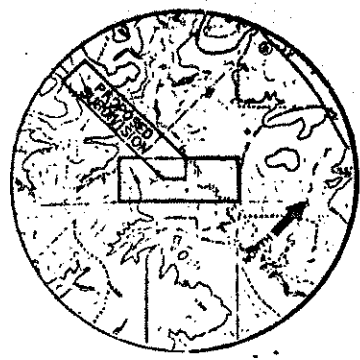
