AMENDMENT TO CONDOMINIUM MAP

NOW, THEREFORE, Declarant has amended Exhibit "A" attached to the Declaration in order to conform the same to the actual locations and designations of such parking spaces, and contemporaneously herewith does file such amended Exhibit "A" in the Condominium Records of Harris County, Texas.

HENCEFORTH, the said Declaration shall be construed as though amended Exhibit "A" had been originally attached to said Declaration.
