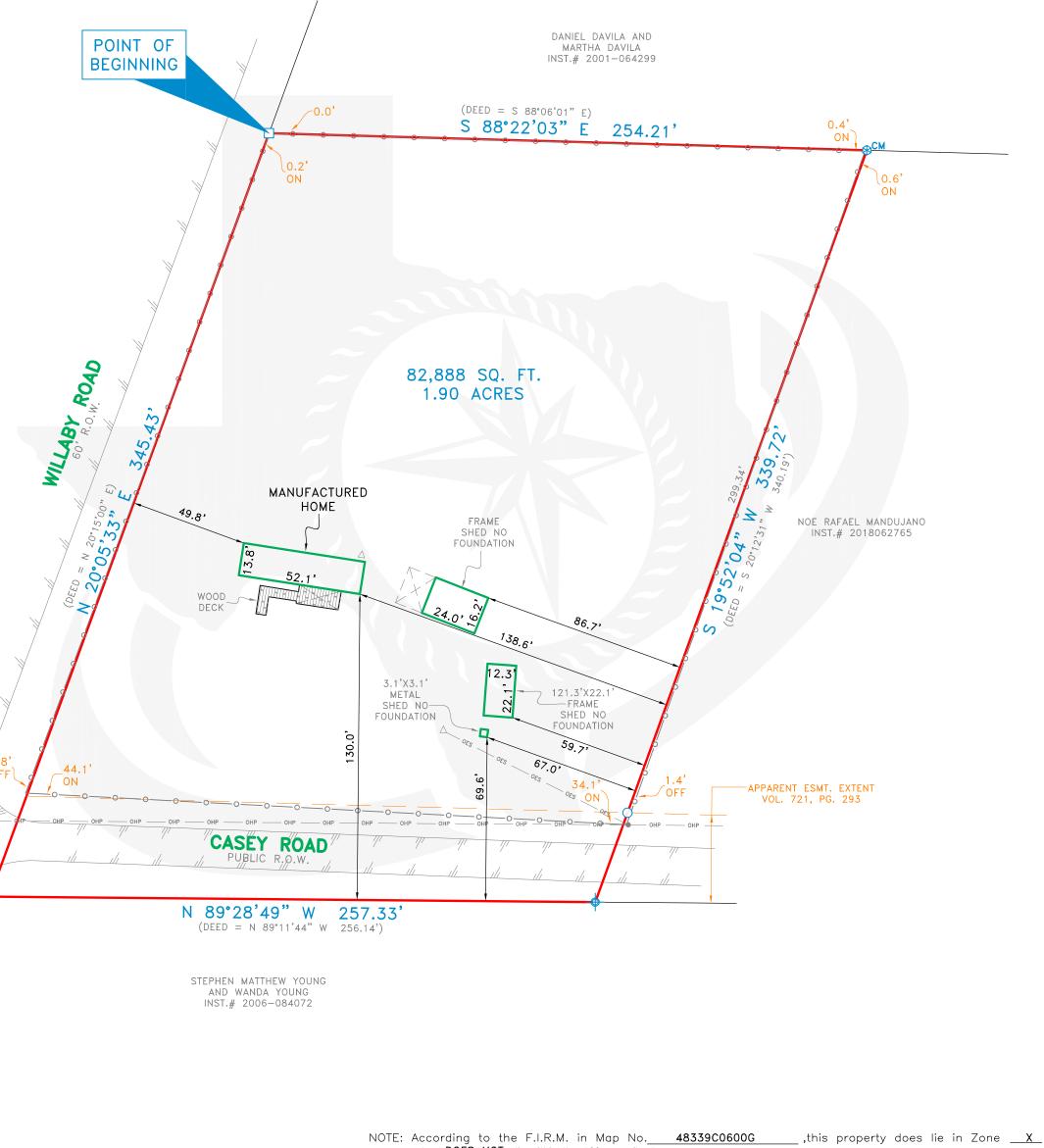

THENCE South 88 degrees 22 minutes 03 seconds East, along the South line of said Davila tract, a distance of 254.21 feet to a point for corner, said corner being the Northwest corner of a tract of land conveyed to Noe Rafael Mandujano, by deed recorded in Instrument Number 2018062765, Official Public Records of Montgomery County, Texas;

THENCE South 19 degrees 52 minutes 04 seconds West, along the West line of said Mandujano tract, passing at a distance of 299.34 feet to a 1/2 inch iron rod found on-line for reference, and continuing a total distance of 339.72 feet to a point for corner, said corner being the Southwest corner of said Mandujano tract, and lying on the North line of a tract of land conveyed to Steven Matthew Young and Wanda Young, by deed recorded in Instrument Number 2006-084072, Official Public Records of Montgomery County,

THENCE North 89 degrees 28 minutes 49 seconds West, along the North line of said Young tract, a distance of 257.33 feet to a 5/8 inch iron rod found for corner, said corner being the Northwest corner of said Young tract, and lying on the aforementioned East line of Willaby Road;

THENCE North 20 degrees 05 minutes 33 seconds East, along the said East line of Willaby Road, a distance of 345.43 feet to the POINT OF BEGINNING and containing 82,888 square feet or 1.90 acres of land.
